- a. **WHEREAS**, District Counsel by letter dated November 29, 2012 requested that Emarinsie Funderburke-Ivy ("EF-I") provide "information and documentation" regarding her organization's (Long Island Youth Foundation) use of school facilities and corporate status; and

**WHEREAS**, legal counsel by letter dated December 31, 2012, advised EF-I that because she failed to respond to the November 29, 2012 letter, the Board of Education had directed him "to advise you that you and your affiliated organizations are prohibited from using any of the facilities of the Roosevelt Union Free School District until further notice," and

**WHEREAS**, the Board of Education has been advised that EF-I has disregarded District Counsel's December 31, 2012 directive and has gone into the schools of the District and distributed flyers for a dance club that she operates without any sponsorship from the District;

**NOW, THEREFORE, BE IT RESOLVED**, that the Board of Education hereby prohibits EF-I from coming onto School District premises for any and all reasons, except to attend meetings or events directly related to her children who are students in the District, in accordance with District policy and its Code of Conduct; and

**IT IS FURTHER RESOLVED**, that should EF-I enter upon the premises of the District in violation of this Resolution, she shall be subject to arrest and prosecution for trespass; and

**IT IS FURTHER RESOLVED**, that a copy of this Resolution will be sent to each school building of the District with instructions to the building administration that it is to be implemented to the full extent of the law.
